Refund Policy:

The refund policy is in effect from the moment the student receives a study permit or visa until the moment he/she officially leaves our program.

All refund requests must be submitted in writing with all supporting documents listed on the Refund Request Form. There will be a C\$100 administrative fee deducted from the total refundable amount. The following refund policy will apply to International Students:

1. Full refund on the program fee, if the study permit and/or visa is not approved by Immigration, Refugees and Citizenship Canada (IRCC). The student must submit a copy of the original IRCC letter of denial.
2. Refund one-half (1/2) of the program fee, if the student withdraws for any reason prior to September 30, 2021.
3. No refund if the student withdraws after September 30, 2021.
4. No refund if the student is found to be in violation of school rules (i.e. chronic absenteeism, drinking alcohol, taking drugs), provincial or Canadian laws.
